By Section 15 of the Union Assessment Committee Act, 1862, it is enacted that "the gross estimated Rental for the purpose of the Schedule to this Act shall be the Rent at which the Hereditament might reasonably be expected to let from Year to Year, free of all usual Tenants' Rates and Taxes, and Tithe Commutation Rentcharge, if any: Provided that nothing herein contained shall repeal or interfere with the provisions contained in the 1st Section of the said Act (6 & 7 William 4, Chapter 96,) defining the net annual Value of the Hereditaments to be

Note.—By Section 1 of the 6 & 7 William 4, Chapter 96, it is enacted that "no Rate for the Relief of the Poor in England and Wales shall be allowed by any justices, or be of any force, which shall not be made upon an estimate of the net Annual Value wares and to move on yarry justices, or so can yarrow, within sain not or mane upon an estimate of the ere at lifered intensit safe thereon to that is to say, of the Rent at which the same might reasonably be expected to let from Year to Year, free of all usual Tennits' Rates and Taxes, and Tithe Commutation Rentcharge, if any, and deducting therefrom the probable average Annual Cost of the Repairs, Insurance, and other expenses, if any, necessary to maintain them in a state to command such Rent: Provided always, that mothing herein contained shall be construct to alter or affect the principles or different relative liabilities (if any) according to which different kinds of Hereditaments are now by law Rateable."
