

A B S T R A C T of the T R U S T  
of F. G. Price, Esq., & Son, Esq., and  
G. Williams the trustees of the Marriage Settlement  
of F. G. Price and S. M. Darrow to the fee farm rents  
in the Isle of Wight.

BY LETTER of this date between the ad William Price of the 1st pt of the ad Georgina Young of the  
2nd pt and FREDERICK YOUNG son of Capt. THOMAS CAREY LYONS of the 1st Brigade Depot at  
Fleetwood in the County of Lancashire a Colonel in Her Majesty's Army and JOHN PRICE of No. 60  
St. James' Street in the City of London the 2nd pt.

RECORDED in a conveyance dated 1st June 1874.

RECORDED that a conveyance had been arranged between the ad Price and the ad G. Young and the same  
was intended to be unexecuted shortly after the date of abstracting presents.

RECORDED that the ad G. Young had been absent from the ad Price's house for some time before the date of  
abstracting.

RECORDED that in reason of the ad intended marriage it was declared that from and after the  
administration of the ad intended marriage the ad F. Young, G. Williams and John Fisher and the survivors  
and survivors of them and the executors or estate of such survivor thereby called "the tree or trees"  
should with the consent of the ad W. Price and G. Young during the joint lives and of the survivor  
of them during his or her life and afterwards at the discretion of the ad tree or trees to invest the  
net money to be produced by the sale of the ad fee farm rents or any of them under the trust for  
use and benefit of the ad tree or trees in the names or name as aforesaid under the legal  
control of the ad tree or trees or a third person and should during the joint lives of the ad Price and  
G. Young pay the ad tree or trees a sum therein and should during the joint lives of the ad Price and  
G. Young pay the ad tree or trees and know the ad tree or trees for the benefit of the ad Price and  
independently of the ad Price and from and after the death of each one of them the ad Price and  
G. Young shall first pay the ad tree or trees the income of the same during his or her life  
and from and after the death of the survivor of the ad G. Young and G. Young should stand possessed  
of the ad trust funds and the tree or trees and income thereof for all and every sum or  
exclusively of the ad tree or trees or the issue of the ad intended marriage to be born during the lives  
of the ad W. Price and G. Young or the life of the survivor of them or within 12 years next after  
the death of the survivor of them at such age or times or respective ages or times if more than one  
in such shares and with such reservations for the respective maintenance education  
or advancement of the ad tree or trees for the time being or of any other person or  
persons and upon such conditions with such restrictions and generally as in such manner as the ad W. Price  
and G. Young should by his or her free and absolute power make known and new appoint  
John Fisher and in default of such appointment then as the ad G. Young if the survive the ad Price  
should make known by his or her will appoint.

RECORDED that until 1st June 1874 several fee farm rents shall have been sold in purchases  
of the trust for the male third parts recited the ad F. Young, T. G. Lyons and J. Fisher or  
the survivors or survivor or of the heirs of such survivor should pay and apply all  
money that may be received on sale of all or any of the ad fee farm rents to the persons  
or persons and for the purpose and in the manner to whom and for and in which the ad trust  
intend and income of the stocks funds charges or securities representing the purchase money

RECORDED that the ad G. Young and G. Williams the trustees of the ad fee farm rents recited in the ad  
settlement with the ad W. Price and G. Young for the time being.

RECORDED that the whole of the income of all the trust property for the time being  
including the ad fee farm rents had been paid to the ad W. Price up to the date of  
abstracting presents as the ad G. Young acknowledge.

RECORDED that the ad W. Price and G. Price in exercise of the power for that purpose given  
to them by the ad intended and of every other power enabling them in that behalf fully  
appointed the ad Francis Mathew Robinson to be a tree of the ad settlement in the place of the ad  
Frederick Young as testifying as to be discharged to act jointly with the ad T. G. Lyons (the  
contingent tree) for all the purposes of the ad settlement.

RECORDED by all parties and attested.

RECORDED abstracting presents were supplemental to abstracted Indr. of 2nd July 1874  
being a conveyance of certain fee farm rents.

RECORDED that about a year later the ad T. G. Lyons and J. Fisher released to the  
Prestwich Turners and Harport Railway Company certain property not affecting his  
share or interest.

RECORDED we are advised of the heritance assured by the ad Conveyance have been  
sold or released.

RECORDED the ad T. G. Lyons was desirous of being discharged from the trust of the ad  
Conveyance as he truly desired and the ad T. G. Lyons and G. Price were desirous of  
appointing the ad Francis Mathew Robinson (who agreed to act) to be a tree in his  
place.

IT WAS WITNESSED that the ad W. Price and G. Price in exercise of the power for that purpose given  
to them by the ad intended and of every other power enabling them in that behalf fully  
appointed the ad Francis Mathew Robinson to be a tree of the ad Conveyance in the place of the ad  
T. G. Lyons as testifying as to be discharged to act jointly with the ad T. G. Lyons (the  
contingent tree) for all the purposes of the ad Conveyance.

IT WAS ALSO WITNESSED that the ad W. Price and G. Price fully declined (and the ad T. G. Lyons and  
Henry George Lyons of the 2nd pt and Arthur John William Powell of Bader's Lodge  
Fleetwood) that the amount of the ad intended should be retained in trust in that behalf fully  
appointed the ad Henry George Lyons to be a tree of the ad settlement in the place of the ad Francis  
Mathew Robinson to act jointly with the ad T. G. Lyons (the contingent tree) for all the purposes of the  
ad Conveyance.

IT WAS ALSO WITNESSED that the ad W. Price and G. Price fully declined (and the ad T. G. Lyons and  
Henry George Lyons) that they severally testified the extent to such declaration that all the estates  
and int'ts of the ad T. G. Lyons in all or any land and in all or any chattel or  
chattel and in all property of every kind then subject to the trust of the ad  
Conveyance and as joint tenants for the purpose and upon the trusts thereof.

RECORDED that there had been 2 children of the ad wife via. Edith May Price  
and Eliza May Price.

AND RECORDED that in view of the ad wife's death and of the ad G. Price as was further contained  
in the ad Conveyance that the ad W. Price and G. Price in exercise of the power for that purpose given  
to them by the ad intended and of every other power enabling them in that behalf fully  
appointed the ad Francis Mathew Robinson to be a tree of the ad Conveyance in the place of the ad  
T. G. Lyons as testifying as to be discharged to act jointly with the ad T. G. Lyons (the  
contingent tree) for all the purposes of the ad Conveyance.

RECORDED that the ad W. Price and G. Price in exercise of the power for that purpose given  
to them by the ad intended and of every other power enabling them in that behalf fully  
appointed the ad Francis Mathew Robinson to be a tree of the ad Conveyance in the place of the ad
