1st The 5 Representative Trustees have to be elected by the inhabitants occupiers of rateable hereditaments whose names are entered in the occupier column of the ratebook in accordance with Sec: 19 of the Poor rate assessment of 1869. These must be resident within the area co-extensive with that of the Ancient Borough of Brading.

A Meeting must be called, as soon as possible, of the electing body ^{by} under the direction of Mr W Riddick.
